Registration of a design takes effect from the Date of Registration, which is backdated to the filing date of the application for registration. Except for associated or corresponding designs, the initial period of registration of a design is 5 years beginning on the filing date of the application for registration. The period of registration may be extended for additional periods of 5 years each but the total period of registration may not exceed 25 years beginning on the filing date of the application for registration.

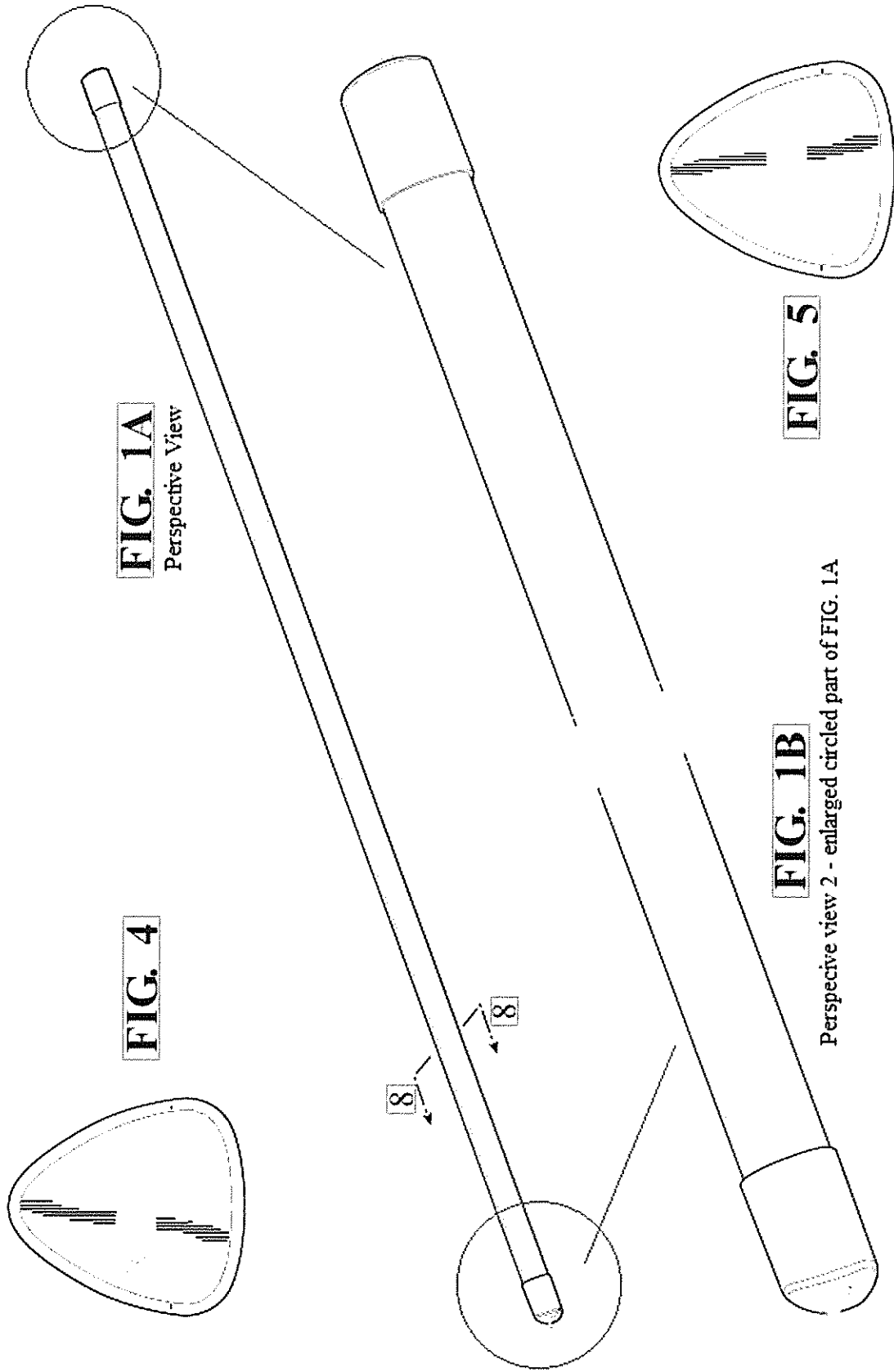

Perspective view 2 - enlarged circled part of FIG. 1A

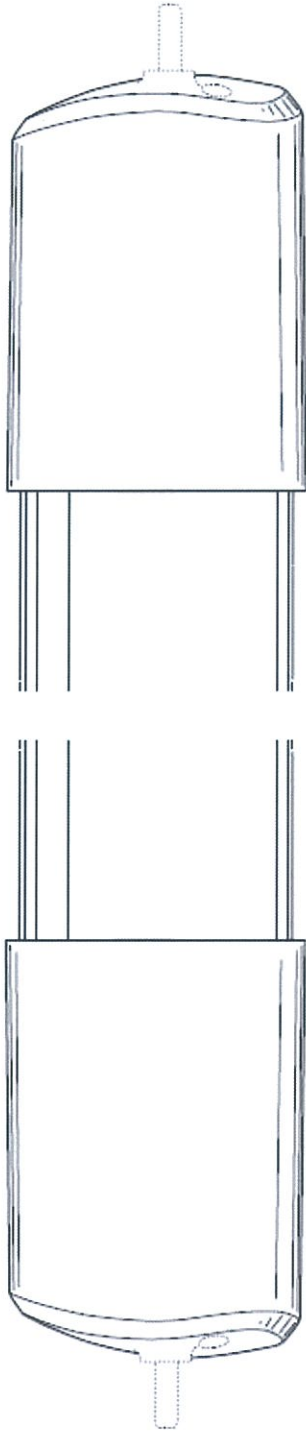

Enlarged circled part of FIG. 1A

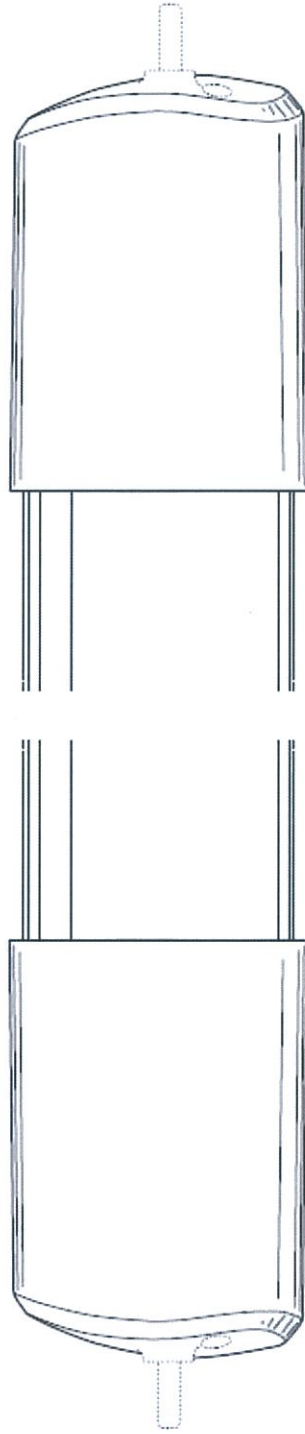

Enlarged circled part of FIG. 1A

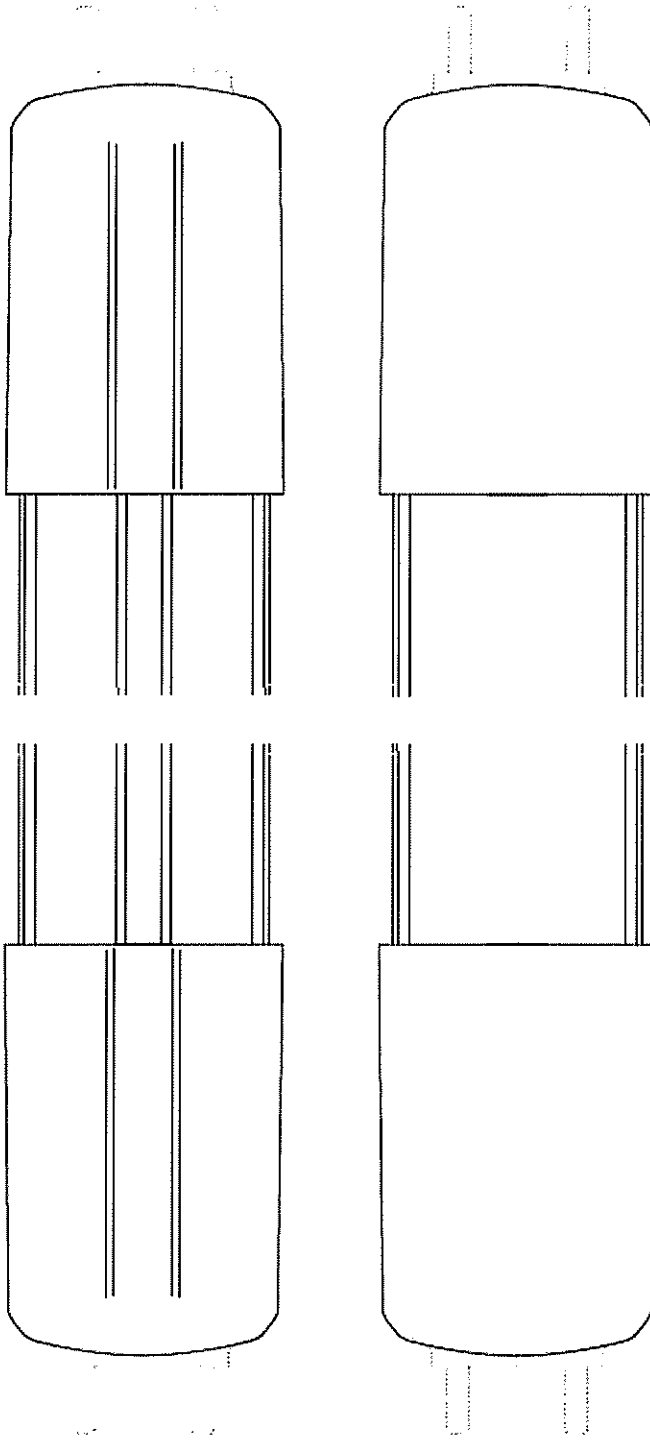


FIG. 7 Bottom View -
Enlarged circled part of FIG. 1A

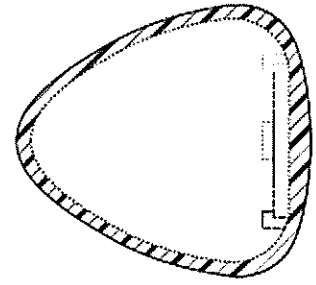
