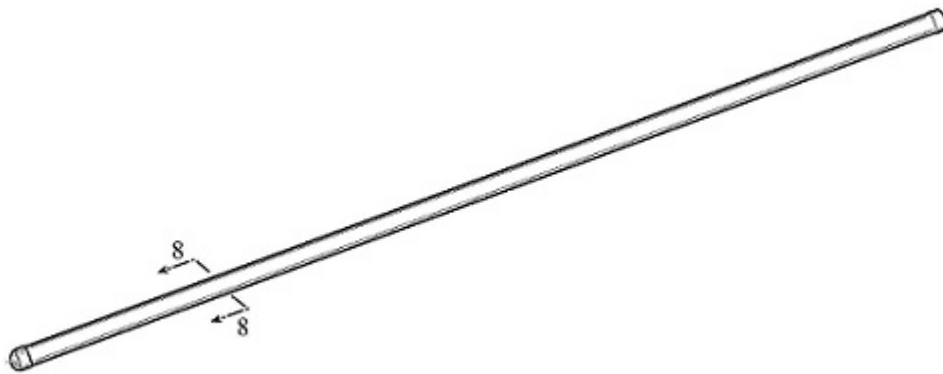

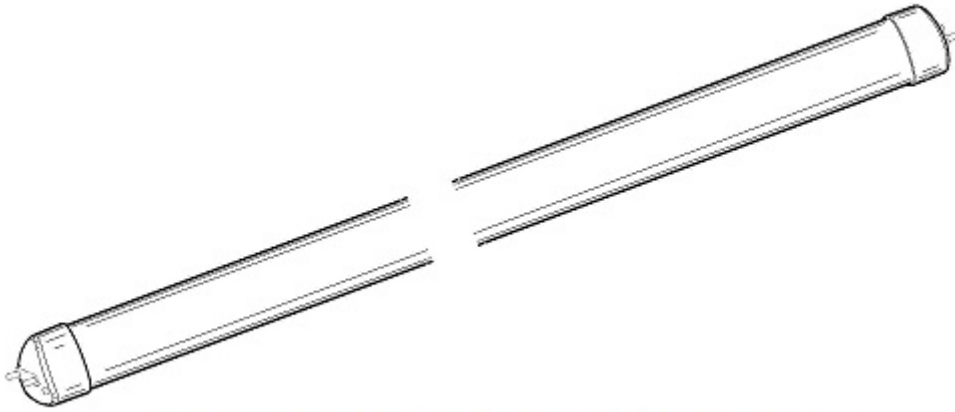

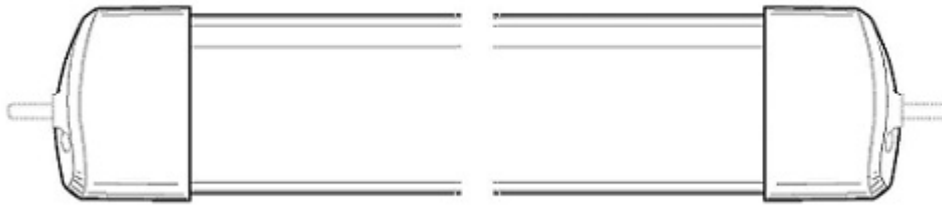
**PERSPECTIVE VIEW**

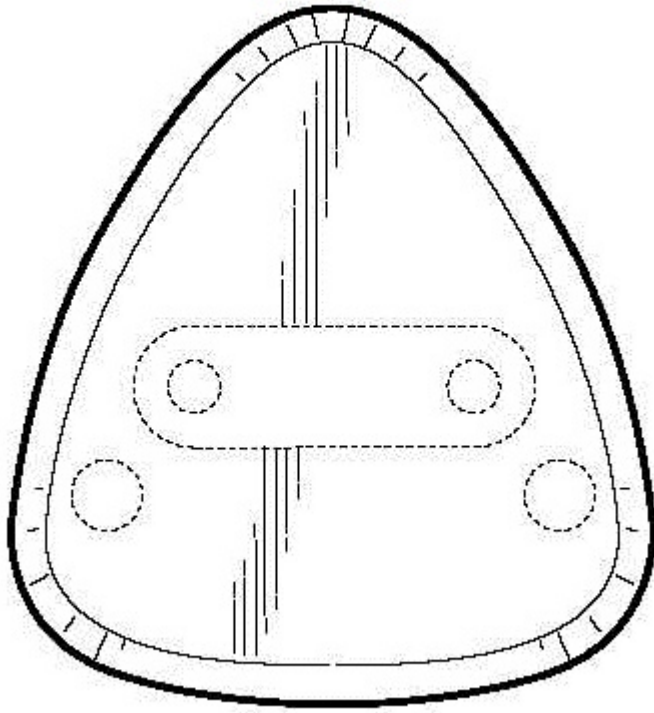
**ENLARGED FRONT ELEVATION VIEW**

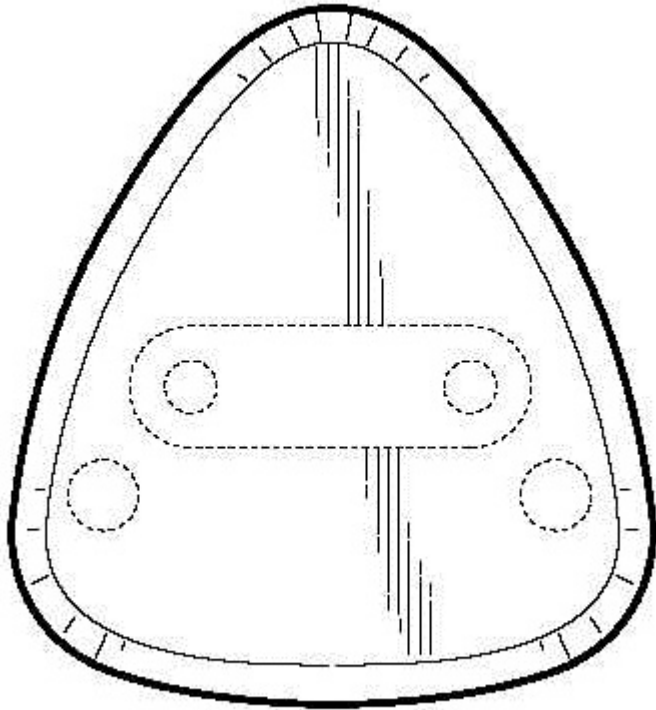
**ENLARGED REAR ELEVATION VIEW**

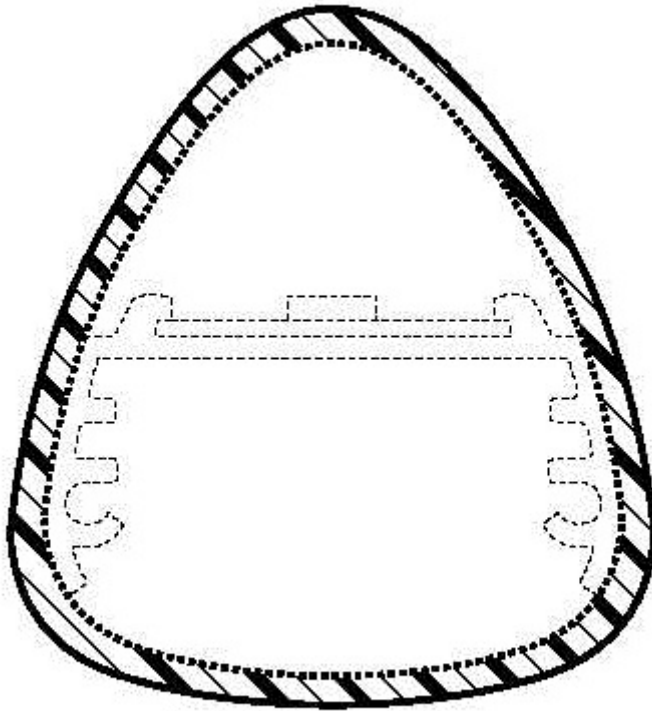
